MEMORANDUM FOR all new members assigned in the Wiesbaden Military Community

SUBJECT: USAG Wiesbaden Command Policy Letter # 34, JKO On-line Training and Testing for Europe Privately Owned Vehicles (POV) Certificate of License

1. References:

- a. AE Regulation 190-1, Driver and Vehicle Requirements and the Installation Traffic Code for U.S. Forces in Germany, 18 Jun 20.
- b. AE Pamphlet 190-34, Drivers Handbook and Examination Manual for Germany 16 Nov 10.
- c. External Standard Operating Procedures for Driver's Testing and Training Station (DTTS).

2. Purpose: To provide clarity in testing requirements for Wiesbaden-assigned personnel to obtain their POV certificate of license.

3. Applicability: This policy applies to all newly assigned personnel (Military, Civilian and Family Members) to the USAG Wiesbaden area of responsibility (AOR). It implements a test approved by HQ USAREUR Office of the Provost Marshal (OPM) and has been coordinated with the U.S. Forces Registrar.

4. Effective Date: Immediately until rescinded in writing.

5. Details: USAG Wiesbaden's safety profile over the past year has shown an increase in vehicle accidents. The number is higher than the USAREUR average and is our highest source of risk for Soldiers, Civilians and Family Members. In response to this data and after evaluating options with the USAREUR OPM, the USAG Wiesbaden Safety Office, the USAG Wiesbaden Directorate of Emergency Services and the Garrison Commander decided to require all incoming newly assigned personnel to attend the training and complete testing at the Wiesbaden Driver's Testing and Training Station (DTTS). Newly assigned personnel who have never been stationed in Europe before will receive POV license training and testing in person at the DTTS office during in-processing. Passing the written test is the requirement to receive a certificate of license to operate POVs in Europe after the initial in-processing period.

6. Policy: Previously assigned personnel to Europe with USAREUR licenses are allowed the exception to utilize the JKO on-line Review and Testing. All new personnel who have not obtained a USAREUR POV license before will attend the 2.5 hour "POV Drivers Orientation" class and pass the 100 question written test in order to obtain a USAREUR POV Certificate of License.

7. DTTS schedule details: Monday morning is reserved for ITC scheduled Soldiers. The orientation and test can be taken on Tuesdays, Wednesdays and Fridays by appointment only. The orientations start at 0730hrs, and ends with the completed test at about 1200hrs.
